Special Event Liability Insurance

- Protection for third-party bodily injury or property damage during an event
- Coverage on a short-term basis for event organizers / promoters or exhibitors
- Coverage on an annual basis for event / meeting planners or exhibitors
- Coverage for vendors / exhibitors associated with a specific tradeshow, convention, fair or festival for only \$65 each
- Standard limits of \$1 million per occurrence / \$2 million aggregate
- Excess limits of up to \$10 million

- Coverage available for sports-related contests, including golf hole-in-one and putting contests, hockey shots, basketball half-court shots and parlays and football tosses and field goal kicks
- Minimum premium: \$150
